Terms, Conditions, Rules & Regulations

1. Competition Overview

The Artssix Open Art Competition is organized to encourage creativity and provide a platform for artists of all age groups and skill levels. The competition is open for participants aged 3 years and above.

2. Competition Categories

Kids Category: 3 – 8 Years

Teenagers Category: 9 – 17 Years

Adults Category: 18 – 35 Years

Learners Category: Open for beginners, hobby artists, and art learners

Professional Artists Category: Open for experienced and practicing artists

3. Competition Timeline

Registration: 25th May – 7th June

Submission Window: 25th May – 7th June

Jury Evaluation: 8th June – 14th June

Winner Announcement: 15th June

4. Registration Process

- Participant must complete the official registration form available on the Artssix website.
 - Correct details such as name, age, contact number, and category must be provided.
 - Participant below 18 years must provide parent/guardian details.
 - Registration will be considered valid only after successful form submission.

5. Artwork Guidelines

- One Person can submit only single artwork.
 - Participant must create artwork for the theme of art competition 'Colors of Gujarat'.
 - Participant must create original artwork only.
 - Copying, tracing, plagiarism, AI-generated replication, or direct imitation of existing artwork is strictly prohibited.
 - Artwork should be created during the competition timeline.
 - Any medium may be used unless otherwise specified.
 - Offensive, inappropriate, hateful, political, or copyrighted content is not allowed.

6. Submission Process

- Final artworks must be submitted within the official submission dates.
 - Artwork will be submit on website submission page in jpeg, png, and webp.
 - Participant must upload clear and high-quality images of their artwork.
 - Late submissions will not be accepted.

7. Jury & Evaluation Process

The jury panel appointed by Artssix will evaluate artworks based on:

- Creativity & originality
- Concept & storytelling
- Composition & presentation
- Technique & execution
- Emotional and visual impact

The decision of the jury panel will be final and binding.

 - Each category winner will receive a cash prize of ₹2000.
 - Artssix reserves the right to feature top artworks on social media, website, exhibitions, and promotional activities.
 - Additional recognition certificates or feature opportunities may be provided.

By participating in the competition, participants agree that:

- Their submitted artwork is original and created by them.
 - Artssix may use submitted artworks, participant names, and photographs/videos for marketing, social media, exhibition, website, and promotional purposes.
 - Participant grant non-exclusive promotional usage rights to Artssix.
 - Participant remain the original owners of their artwork unless otherwise agreed separately.

11. Disqualification Rules

Artssix reserves the right to disqualify participant if:

- False information is provided during registration.
 - Artwork is copied, plagiarized, or AI-generated without disclosure.
 - Submission violates competition guidelines.
 - Any inappropriate behavior or misconduct occurs.

 - Artssix shall not be responsible for technical issues, upload failures, or internet-related problems during submission.
